

# Privacy policy

Our Privacy Policy applies to all services offered by **ICOscoring** and its affiliates, unless specifically excluded. This policy describes how we treat and use customer and/or user information we collect when you visit our website, use our services and/or receive any email from us. Also, this policy explains how to access and update information. By using any **ICOscoring** services or our website, you indicate that you accept this policy and any applicable agreement incorporated by reference.

## 1. YOUR PERSONAL INFORMATION COLLECTED BY ICOSCORING

1.1. We require certain information to allow us to process your registration, log-in process (including the sign-in process with your existing account through third-party service providers) to or your usage of **ICOscoring's** website or any other services provided by us. We collect publicly-available details, also provided by you directly, indirectly or via third parties (including Crunchbase). To provide you with the services, we may also request and/or collect personal information such as your name, geographical coordinates, email, telephone number, age and occupation, credit-card information etc.

1.2. We collect personal information when you sign up, log in, use or visit our pages, and when you click on links on our pages. We may collect additional information in connection with your participation in any services offered by us, third parties and information you provide when giving us feedback. We may use your information to send you offers and news about **ICOscoring** products and services or those of other selected companies which we think may be of interest to you.

1.3. Your data may be used for the following purposes: user on-boarding or sign-in process, either directly or via third-party service provider, providing our services to you and arranging transaction you have made through the platform; monitoring your usage of **ICOscoring** Services; accounting, billing and audit, credit card or other payment-card verification and screening; security, administrative and legal purposes; statistical and marketing analysis; systems testing, maintenance and development; customer surveys, customer relations, and to help us in any future dealings with you, by identifying your requirements and preferences, for example. We may share your personal and identifiable information with persons belonging to **ICOscoring** group and also with our service providers whom we have contracted to assist us in providing the services, including statistical and marketing analysis. We may also share your information with the companies which raise capital through the platform, and also with other users of the platform, for the purposes of facilitating transactions on the platform. We may also share this information with others, such as advertisers interested in on our site, in aggregate, anonymous form, which means that the information will not contain any personally-identifiable information about you or any other person.

1.4. We may contact you by post, email or telephone (including SMS) for these purposes. Your confirmation emails may include marketing material which we may feel will be of interest to you from third parties.

1.5. If you do not wish to receive any longer any marketing or promotional communications, you may always opt out in the communications preference section of your account, send us an e-mail or click an unsubscribe link in the e-mail sent to you. 1.6. **ICOScoring** does not collect any other personal and publicly unavailable information that you do not expressly provide. **ICOScoring** will not sell, rent or share your personal information, including your email address, with any third parties for marketing purposes without your permission.

1.7. We may share your personal information to contact you by postal mail, email, telephone, or any other form of electronic or non-electronic communication, as required by law. Though we make every effort to preserve user privacy, we may need to disclose personal information when required by law and when we have a good-faith belief that such action is necessary to comply with judicial proceedings, a court order or legal process that we receive. We may also collect demographic and other data, which may include personally-identifiable information, generally through surveys and forms which you may or may not choose to participate in.

## 2. PROFILE PAGE

If you choose to sign up for a **ICOScoring** account, you may or may not already have a personal or corporate profile page on our site, containing the name and basic information about the company you work for, the business you working with, or your own name if you're working independently. You may also add other information to your profile, describing and illustrating your business, activities, team, etc. If you are a private person with a personal account, you may delete your account or ask us to limit the usage of your profile. Links to your profile page may be included on **ICOScoring's** pages. Certain information about each user or member will be included in that user's or member's public profile and may be accessible to anyone visiting that profile page on our website. ## 3. USAGE INFORMATION

In addition to collecting personal and non-personal information, we may also collect non-personal, aggregated information about subscribers' and users' use of our site. This information is not personally identifiable and will only be used to find out how our services and website are used. For example, this information may include how much time users spend on our site, from which other sites subscribers came, and to what other sites subscribers go. The collection of this information allows us to, among other things, prepare for traffic-load demands and to efficiently deliver relevant information.

## 4. COOKIES AND TRACKING

4.1. We may make use of browser "cookies." These are small pieces of information that are stored by your browser on your computer's hard drive when you visit our site. They allow us to see if you have logged in, checked your status as a subscriber or user, and facilitate access to your preferences. Cookies can be deleted from your hard drive if you wish. Most web browsers automatically accept cookies, but you can change your browser settings to prevent that. However, please note that certain parts of this web-site will not function properly if usage of cookies is blocked. **ICOScoring** is not liable for any loss of functionality or quality of this web-

site if usage of cookies is blocked. We may also use transparent GIF images. We would use these images to track the emails that we send.

4.2. In the course of serving advertisements to this site, our third-party advertisers may place or recognize a unique cookie on your browser.

4.3. We may also use tracking software to monitor customer traffic patterns and site usage to help us develop the design and layout of the site, and also to keep you informed of our activities.

## 5. REVIEW AND ACCESS

## 6. IP ADDRESS

When you visit our site, we log standard information such as your IP address, which is a number that can be used to identify your location and Internet Service Provider, along with the URL from which you came to our site and the URLs visited on our site. A URL is the full address of a web page, which may or may not contain some personally identifiable information about the person who is viewing it.

## 7. BUSINESS TRANSITIONS

In the event **ICOscoring** goes through a business transition, such as a merger or acquisition by another company, or sale of a portion of its assets, users' personal information will, in most instances, be part of the assets transferred.
